Tenderers/Bidders eligibility requirements:

1. Company Age and Registration:

- **Operational History:**
 - The applicant must be a registered entity (proprietorship, partnership firm, or corporate) with a minimum operational history of three (3) years as of the tender submission date.
- **Supporting Documents:**
 - Certificate of Registration / Trade License.
 - Incorporation Certificate or Registration Certificate issued under the Companies Act, 2013, or an equivalent statute.
- **GST Registration:**
 - The entity must be registered under GST.
- **Supporting Documents:**
 - Valid GST Registration Certificate.
 - GST compliance records, such as GST Returns for the last 2–3 financial years, may be required for verification.
- **PAN and TAN Details:**
 - The applicant must possess valid Permanent Account Number (PAN) and Tax Deduction and Collection Account Number (TAN) issued by the Income Tax Department.
- **Supporting Documents:**
 - Copies of PAN and TAN cards.

2. Credentials and Supporting Documents:

- **Financial Turnover and Audit Reports:**
 - Applicants must provide evidence of financial stability, including:
 - Audited Balance Sheets and Profit & Loss Statements for the last three (3) financial years.

- **Supporting Documents:**

- Copies of audited reports certified by a Chartered Accountant.
- Income Tax Return (ITR) acknowledgments.

3. Financial Requirements:

(A) Earnest Money Deposit (EMD):

- An EMD of ₹5,00,000/- (Rupees Five Lakhs) must be submitted as a refundable deposit to secure participation in the bidding process.
- **Payment Method:**
 - Electronic transfer via the Karnataka e-Procurement portal.
- **Proof:**
 - Online payment receipt.

(B) Advance Payment Upon Tender Award:

- Upon successful award of the tender, the buyer must deposit advance payment towards the value of the quantity of sand intended to be lifted (delivery of the sand consignment is only against the advance payment).

(C) Tender Document Fee:

- A non-refundable fee of ₹500/- must be paid for accessing the tender documents.
- **Payment Method:**
 - Online payment through the Karnataka e-Procurement portal.
- **Proof:**
 - Payment receipt generated on the portal.

(D) Upon successful award of Tender: The buyer must remit a sum of Rs.25.00 lakh (Twenty Five lakh) as security deposit in the form of a DD or a Bank guarantee in favour of MSIL. The said security deposit shall be adjusted against the final clearance value of the sand. In case of default in any for not lifting the entire sand stock, the security deposit is liable to be forfeited for which the buyer shall not raise any dispute.

(E) Time limit to lift the entire sand stock from the port premises is fixed as **120 days** from the date of work order/Letter of Intent. However, further 30 days grace period shall be granted on mutual consent to complete the pending task if any. However, the buyer will be extended all co-operation to lift the sand at the earliest possible. If the buyer fails to perform the tender task within the above time schedule, the buyer is liable to bear all the port charges that may be levied by the port authorities on stand-alone basis without any liability on MSIL.

(F) The successful tenderer/buyer should co-ordinate with the port authorities for day-to-day movement of sand stock from the port premises in due compliance to the port regulations.

4. Additional Compliance Requirements:

1. Affidavit for Non-Litigation/Non-Blacklisting:

- A notarized affidavit (on ₹100/- stamp paper) confirming:
 - No pending litigation with any government entity.

- The applicant has not been blacklisted by any government or semi-government authority.
